Challenges

Empowering local banks with secure, cost-effective solutions for compliance

Banks in Nepal often lack the in-house expertise to manage EFT Switching Technology and Card Issuing infrastructure internally. This necessitates a third-party Technology Service Provider (TSP) to handle end-to-end transaction processing, including transaction handling, managing debit/credit, reconciliation, and settlement with major schemes. Additionally, these banks required cost-effective services delivered in a Software as a Service (SaaS) model.

For SCT, the challenge was twofold: delivering a secure environment that complies with a broad range of stringent PCI standards, and protecting Personal Identifiable Information (PII) from unauthorized access, hacking, and theft.

To address these challenges, SCT needed to set up a full-fledged and secure environment to serve their banking customers in Nepal. Given the stringent requirements for security and compliance, SCT chose Thales payShield 10K HSM for their environment to provide robust security for transaction processing.

payShield 10K is a payment hardware security module (HSM) used extensively throughout the global payment ecosystem by issuers, service providers, acquirers, processors and payment networks. It plays a fundamental security role in securing the payment credential issuing, user authentication, card authentication and sensitive data protection processes for both face-to-face and digital remote payments.

The decision was significantly influenced by regulatory requirements and payment industry-specific requirements, including compliance with PCI DSS and PCI PTS, which mandated a secure and compliant processing environment, crucial for SCT's operations. In addition, Thales was selected due to its strong network of local partners in Nepal who provided the necessary support for such a businesscritical deployment.
