THE SOFTWARE IS BEING PROVIDED TO LICENSEE HEREUNDER FOR TESTING PURPOSES AT NO CHARGE, AND THALES IS UNDER NO OBLIGATION TO PROVIDE ANY SUPPORT OR RELATED SERVICES WITH RESPECT TO THE SOFTWARE.

1. LICENSE

The Software that accompanies this Agreement is the property of Thales and/or its licensors, and is protected by various patent, trade secret and copyright laws, contractual arrangements and international treaties. The Agreement herein grants to the company you represent and/or by which you are employed ("Licensee" or "you") certain non-exclusive, non-transferable rights to use the Software in conjunction with Designated Thales Hardware (as defined herein) solely for internal, non-production, testing purposes only and subject to Licensee's full compliance with the terms and conditions of this Agreement. All rights not expressly granted under this Agreement are reserved by Thales or its licensors, as their interests appear. ALL INTELLECTUAL PROPERTY AND CONTRACT RIGHTS TO THE SOFTWARE SHALL REMAIN WITH THALES AND/OR ITS LICENSORS. The protections set forth in this Agreement apply to Thales and its affiliates, licensors, dealers and suppliers.

1.1 Subject to the terms and conditions of this Agreement, Licensee may, during the term hereof, install and use the Software solely in Licensee's internal, non-production test environment in conjunction with Designated Thales Hardware, in up to twenty (20) authorized hardware security module partitions ("HSMPs," or, singularly, "HSMP") expressly authorized by Thales. For purposes of this Agreement, a "Client" means a single computer connected directly to the applicable Designated Thales Hardware (the "original computer"), or a single computer connected to the applicable Designated Thales Hardware though the original computer, either of which is running one or multiple processes which utilize the cryptographic processing occurring on the applicable Designated Thales Hardware. For the purposes of this Agreement, an "HSMP" means the feature of the Thales product that enables multiple independent virtual hardware security modules to be hosted on or within the cryptographic engine of the applicable Thales product. HSMPs each maintain their own data and access control policies in protected memory partitions. Any violation of Section 1.2(a), (b), (c), (d), (f), (g) or (h) hereof shall automatically convert this Agreement into one for the fee-based Premium version of the Software and all charges and limitations relating to such version as well as the automatic activation of Thales' support agreement and attendant charges. A violation of Section 1.2(e) shall constitute a material breach hereof and subject Licensee to all damages available to Thales as well as the right to enjoin any further activity with respect to the Software. In any such event, Licensee shall be responsible for all costs and expenses of Thales, including recovery from Licensee of all attorneys' fees and expenses. Upon request from Thales at any time, Licensee shall provide to Thales a certification, executed by a senior officer, as to the number of HSMPs in operation and the use to which the Software is being put. Failure to respond within ten (10) days to such request for information by Thales shall be grounds for the automatic termination of the Agreement upon written notice from Thales.

12 Except as otherwise expressly stated in this Agreement, Licensee may not:

- a. use or deploy the Software in any production, or non-test environment;
- b. copy the Software;

- c. copy the documentation, which accompanies the Software, for purposes outside the scope of this Agreement, or disclose the same to any third party;
- d. transfer, assign, sublicense, rent or lease any portion of the Software;

- e. reverse engineer, decompile, disassemble, translate, copy, modify, alter or otherwise change any Software or any accompanying hardware (except to the extent this restriction is not permitted by applicable law and, in such case, Licensee may only do so to achieve interoperability with other software programs disclosed to Thales in advance, and for no other purpose). Licensee shall have no right to obtain source code for any software provided by Thales;
- f. modify, translate, or create derivative works from the Software, merge all or any part of the Software with any other software, or separate the component parts of the Software;
- g. directly or indirectly use the Software or any information about the Software in the development of any product; or
- h. load or use any portion of the Software (whether modified or incorporated into or with other software) on or with any machine or system other than the applicable Designated Thales Hardware or authorized Client.

5. TERM AND TERMINATION OF THIS LICENSE

The non-exclusive and limited License granted hereunder shall remain in effect only for so long as Licensee is in compliance with the terms and conditions of this Agreement, and in any event until twenty (20) days after notice from Thales of the termination thereof for any reason or no reason. Upon termination or expiration of this Agreement Licensee will immediately destroy the Software, purge all copies of the Software and all copies thereof from all computer systems and storage devices on which it was stored or return all copies of the Software to Thales and provide Thales certification of such destruction or return, at Thales' request, via an affidavit or statutory declaration signed by an officer of Licensee's company. The following Sections of this Agreement

This Agreement shall for all purposes be governed by and interpreted in accordance with the laws of State of New York, USA. The Convention on Contracts for the International Sales of Goods does not apply.

(i) In the event of any dispute which arises solely between the parties hereto, arising under, relating to or in connection with the Agreement or the limited License, or the enforcement or interpretation of any provision of the Agreement, or the breach or alleged breach by either party of its obligations thereunder, such dispute will be referred to and finally determined by arbitration in accordance with the JAMS International Arbitration Rules. The Tribunal will consist of three arbitrators. The place of arbitration will be New York, New York, USA. The language to be used in the arbitral proceedings will be English. Judgment upon the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof. The arbitration award shall be final and binding upon the

parties and judgment on any award may be entered in an appropriate federal court located within the County of New York, State of New York, to which the parties consent, or enforced outside of the United States in accordance with the Convention on the Recognition and Enforcement of Foreign Arbitral Awards, in any court of competent jurisdiction. All arbitration proceedings, and all documents, pleadings and transcripts associated therewith, shall be kept strictly confidential by all parties, their counsel and other advisors, employees, experts and all others under their reasonable control. This clause shall not preclude parties from seeking provisional remedies in aid of arbitration from a court of appropriate jurisdiction.

(ii) In the event that a third party brings an action or other proceeding against either party to this Agreement or asserts a cause of action in any action or proceeding initiated by either party to the Agreement against it (a "Third Party Action"), then the party to the Agreement against which or whom such Third Party Action is brought or asserted, may, in such Third Party Action, or separately in any court of competent jurisdiction, assert any related claim which it may have against the other party to the Agreement, including, without limitation, by way of a claim, indemnity, cross-claim, counterclaim, interpleader or other third party action without being obligated to arbitrate the same as otherwise provided in Paragraph (a) hereof. In any such case, the matter which is the subject of such Third Party Action (including any related claims, indemnity, cross-claim, counterclaim, interpleader or other third party action, which either party hereto may have against the other) shall not be subject to arbitration, but shall be resolved exclusively within such Third Party Action or, at the election of the asserting party.
